Mr. Lundwall presented the collaborative's Re-Opening plan submission to the Department of Elementary and Secondary Educational (DESE). Mr. Lundwall reviewed what occurred on SWCEC campuses during the in-person Extended School Year. The plan uses a phased in approach and will be adjusted as necessary. The first 6-weeks will operate as the ESY program had. If this is successful, phase two (2) will have students on both campuses for four (4) days of in-person learning for the next 6-week period.
