## **Executive Director's Report**

1. Personnel

Mr. Lundwall informed the membership that the Director of Finance & Operations interviews have concluded and he will be presenting the candidate for Board appointment at the March meeting. Mr.

Lundwall spoke about the other open positions, stating like most collaborative and school districts we are experience a smaller than average number of applicants. The positions have been open for a length of time and he is not anticipating filling them in this fiscal year.

## 2. Enrollment/Staffing

SWCEC had an enrollment of 114 students as of January 31, 2020, a loss of four enrollments since the January meeting. These loses were due to moves, transition back to districts and post-graduate terminations.

## 3. Program Update

Mr. Lundwall spoke about the informative professional development presented by Dr. Maureen Cohen, Engaging Students Through Student Agency and Project-Based Learning on January 15, 2021. Unlike in January, SWCEC did not take a remote learning week after the February vacation and experienced no issues. To date there have been 15 cases with no in school transmission. Mr. Lundwall informed the Board that SWCEC has received a letter from DESE stating that all FY 20 annual report requirements were met.

 Massachusetts Collaborative Update Mr. Lundwall informed the membership that the Board of Directors of EDCO recently voted to dissolve the Collaborative. This lengthy process should conclude by June 30, 2022. A brief discussion was held.

#### **Financial Operations Report**

- 1. Mr. Love spoke about the financial health of SWCEC. The current deficit is due to lower than projected enrollment figures. The financial situation will continue to be monitored.
- 2. Mr. Love informed the Board that SWCEC has received a letter from DESE stating that all FY 20 audit requirements were met.
