Meeting Minutes April 14, 2023

#### **Approval of Minutes**

Dr. Myers made a motion to accept the minutes of March 17, 2023, 2023. Seconded by Ms. Boyd. The vote was carried 8-0-0.

#### **Executive Director's Report**

#### 1. Personnel

Mr. Lundwall shared that the Facilities Supervisor resigned. There are a couple of leads with interviews happening shortly.

The Teacher of Visually impaired remains open. Director of Special Services, Dennis Todd, is looking at districts to determine needs going forward.

#### 2. Enrollment

SWCEC's rate of referrals remains at the same pace as last year, current enrollment is steady at 119. Mr. Lundwall inquired about the current need of districts. More than one district mentioned they would be interested in an in-house program that would help support their long-term suspensions.

Mr. Lundwall & Ms. Travinski are continuing to meet with superintendents in their districts.

#### 3. Program Update

Eight students are graduating for SWCEC this year on May 31<sup>st</sup> at the Sturbridge Host. The Districts with students include Dudley Charlton RSD, Tantasqua RSD, Leicester, Northbridge and Southbridge. Mr. Lucas asked that a calendar invitation to the superintendents be sent.

SWCEC's Specialize Developmental students are again participating in Special Olympics on May 19<sup>th</sup> in Leicester.

The Collaborative Program review mid cycle DESE report came back with no errors of corrective action. The next review will not be for three years.

Auburn Elks gave the GCDP program a grant for \$1500 to purchase additional lawn equipment. At their next meeting they are considering SWCEC for funding for the Elementary playground.

## 4. Board Meeting FY24 Calendar

Ms. Boyd made a motion to accept the FY24 Board Meeting calendar. Seconded by D. Meyers. The vote carried 8-0-0.

Dr. Meyers asked that the calendar invitation be sent out to all board meetings in advance.

### **Financial Operation Report**

- 1. FY 2023 Balance Sheet & Operation Statement Ms. Travinski reminded the board that the accrued wages are not reflected in financial statements. Collaborative billed out 1.79 million for Q4 tuition, slightly more than estimation.
- 2. Grants Received for Elementary School Playground
  The Elementary School landlord E& M Realtors donated \$10,000 to the purchase of playground equipment. The Tri- County Exchange Club donated \$1,000 to the new playground.

Dr. Meyers made the motion to accept the E&M Realtors donation of \$10,000 and The Tri-County Exchange club donation of \$1000. Seconded by Dr. Chamberland. The vote carried 8-0-0

#### **SWCEC Executive Director Evaluation**

The Chairman thanked the board for providing feedback to the Executive Director's evaluation. Overall, it was felt that the Executive Director Lundwall was doing a really good job. Things are running smoothly. The Board expressed their thanks.

Dr. Meyers asked that next year Mr. Lundwall to showcase his evidence towards meeting the goals at each board meeting. Dr. Robers-Morandi shared she uses a live document to update her evidence and it is shared with her Schools Committee members.

Ms. Boyd stated that the Executive Directors's contract renewal will be discussed at the May Board meeting.

Mr. Larmarche made a motion to accept the Executive Director Evaluation. Seconded by Dr. Meyers. The vote carried 9-0-0.

Dr. Chamberlain made a motion to adjourn at 2:30 pm. Seconded by Ms. Boyd. The vote was carried 9-0-0.
